ORDINANCE NO. -2021

AN ORDINANCE AMENDING THE CITY OF MILLVILLE CODE, CHAPTER 17 ("FIRE DEPARTMENT"), ARTICLE I, SECTION 17-6 ("COMPOSITION OF THE FIRE DEPARTMENT") TO INCREASE THE MAXIMUM AGE FOR THE APPOINTMENT OF VOLUNTEER FIRE FIGHTERS FROM 55 TO 60.

WHEREAS, Millville City Code Chapter 17 ("FIRE DEPARTMENT"), ARTICLE I, SECTION 17-6 ('COMPOSITION OF THE FIRE DEPARTMENT") at present limits the age of persons eligible to be selected as a regular volunteer fire fighter to those not under the age of 18 nor over the age of 55 years; and

WHEREAS, N.J.S.A. 40A:14-56 was amended effective January 1, 2009 to allow eligibility to an exempt fireman certificate to persons who at the time of their appointment were not over 60 years of age; and

WHEREAS, the Board of Commissioners finds it to be in the best interest of the City Fire Department to increase the age of eligibility for the appointment of volunteer fire fighters from 55 to 60 years of age.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Millville that Millville City Code, Chapter 17 ("FIRE DEPARTMENT"), Article I, Section 17-6 ("COMPOSITION OF THE FIRE DEPARTMENT") is hereby amended as follows:

SECTION 1

§ 17-6 Composition of the Fire Department.

The Fire Department of the City is composed of paid firefighters, regular volunteer firemen and trainee members.

- A. Paid fire fighters. Paid fire fighters shall be appointed by the Director of Public Safety from a list of candidates supplied by the Civil Service Commission. No person shall be appointed as a paid member or officer who is under 21 or over 35 years of age pursuant to N.J.S.A. 40A:14-12.
- B. Regular volunteer fire fighters. Volunteer fire fighters shall be appointed by the Director of Public Safety. New applicants for this position must submit an application to the City Clerk which satisfies the general qualifications required by New Jersey State statutes. No person shall be selected as a regular volunteer fire fighter who is under 18 or over <u>60</u> years of age.
- C. Trainee members. The number of trainee members shall not exceed 15 members. New applicants for this position must be reviewed and approved by the Investigative Committee of the Millville Fire Department. Final approval must be made by the governing body of the City. The trainee member shall serve a probationary period of not less than one year and shall successfully fulfill all of the requirements set forth in the Constitution of the Millville Fire Department before being eligible for regular volunteer fireman. No person shall be selected as a trainee member who is under 18 years or over 55 years of age.

SECTION 2

Should any provision of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the

ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

SECTION 3

This ordinance shall take effect twenty (20) days after final passage, according to law.

AN ORDINANCE ENACTING NEW ARTICLE III ("CITY OF MILLVILLE DOG PARK") TO CHAPTER 8 OF THE CITY CODE

WHEREAS, the Board of Commissioners of the City of Millville finds that there is a public demand for a dog park where City residents can take their pets to socialize with other dogs; and

WHEREAS, before such a park can be opened to the public, there is a need to establish rules and regulations governing the operation of such a facility or facilities; and

WHEREAS, the Board of Commissioners finds it to be in the best interest of City residents and their pets to establish such rules and regulations to provide for the safe operation and use of any such park including the one proposed at the City of Millville recreational facility at Union Lake Park.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Millville that Millville City Code, Chapter 8, Article III ('CITY OF MILLVILLE DOG PARK") shall be enacted as follows:

SECTION 1

§ 8-31 ESTABLISHMENT OF DOG PARK.

The City of Millville Dog Park, the use of which is governed by this article, is established and shall consist of a fence-enclosed area within the confines of Lot 127, Block 236, known as Union Lake Park, 1414 Canal Street, Millville, New Jersey

§ 8-32 DEFINITIONS.

Unless otherwise specifically defined herein, words and phrases in this article shall be interpreted so as to give them the meaning that they have in common usage and to give this article its most reasonable application. The following terms shall have the meanings indicated:

DOG LICENSE

A current license issued by a governmental authority which represents that a dog has a valid, unexpired rabies vaccination. For information about licensing see Article I of this Chapter 8.

DOG PARK PERMIT

A current Dog Park Permit issued by the City Clerk which allows a Keeper to admit a dog into the Dog Park.

KEEPER

Any person exercising control over a dog or permitting a dog to enter the Dog Park or permitting a dog for which he or she is responsible to remain in the Dog Park. The owner of a dog is also its Keeper.

§ 8-33 ACCEPTANCE OF RISK, RELEASE AND WAIVER REQUIRED.

By entering the City of Millville Dog Park, any person agrees to accept the risk for any actions taken by or to himself or herself or his or her respective dog. As part of the application process, all dog owners are required to sign a release and waiver of liability indicating they accept all risk and indemnify and hold harmless the City of Millville, its agents, officers and employees. All dog owners shall be strictly liable and responsible for any actions of their dogs, including any which cause injury to other dogs or persons while in or about the dog park of the City of Millville. The form for the acceptance of risk, release and waiver shall be as approved by the City Solicitor.

§ 8-34 FEES.

- A. The Dog Park Permit fee shall include the cost of application as well as use of the Dog Park for the term of one year, which shall run, no matter the time of the application or issuance of such Dog Park Permit, from January 1 to December 31
- B. The annual, nontransferable Dog Park Permit fee shall be \$10.00 per dog.
- C. In the event that a Dog Park Permit is lost or stolen, the replacement price shall be the full price of the Dog Park Permit.

§ 8-35 PERMIT REQUIRED; APPLICATION.

- A. No person shall utilize the Dog Park in any manner whatsoever without first obtaining from the Office of the City Clerk a Dog Park Permit for each dog. Application for a Dog Park Permit shall be made on forms provided by the Office of the City Clerk. Keepers applying for a Dog Park Permit shall present to the City Clerk the following:
- (1) A current dog license for each dog to be admitted to the Dog Park;
- (2) Proof of current rabies vaccination for each dog to be admitted to the Dog Park;
- (3) Signed acceptance of risk and release of liability form;
- (4) Proof of current, valid homeowner's or renter's insurance with liability coverage;
- (5) Governmentally issued identification establishing that the Keeper is not less than 18 years of age;
- (6) The required fee; and
- (7) Such other information as may be required by rules and regulations adopted pursuant to this article.

§ 8-36 DOG PARK HOURS.

The Dog Park will be open for use from dawn until dusk, seven days per week.

§ 8-37 RULES AND REGULATIONS

- A. The City of Millville shall promulgate rules and regulations which may be enforced by any member of the Police Department of the City of Millville, the Department of Parks and Public Property of the City of Millville or the City of Millville Animal Control Officer. Said rules and regulations shall include, at a minimum, the following:
- (1) All Keepers, including the owner of any dog assumes all liability for damages to person or property caused by the dog for which they are responsible at and about the Dog Park, including injury suffered by anyone or any dog who is bitten or injured by their dog while utilizing the park or any dog allowed to access the park with the Keepers Dog Park Permit and shall hold the City of Millville harmless for same
- (2) All Keepers including the owner who utilizes the Dog Park do so at their own risk of injury to selves and dogs. No attendant is on duty.
- (3) Remove leashes in the designated "Unleash Area" only.
- (4) Dogs must be supervised at all times by persons eighteen (18) years or older.
- (5) No children under the age of fourteen (14) shall be in the designated "Unleash Area."
- (6) No unattended dogs are permitted in the park at any time abandoning animals is prohibited by law.
- (7) No more than two (2) dogs are permitted per Keeper at one time in the park.
- (8) All Keepers must accompany & monitor their dog's actions closely at all times and always have a leash ready & available for use as may be required.
- (9) No smoking, alcohol, food or glass containers are permitted in the Dog Park. All personal property, debris, garbage and other wastes brought in or created by any Keeper, guest, or dog shall be promptly removed at the end of each visit to the site. Pooper Scooper bags are available in the park.
- (10) Aggressive dogs are prohibited from utilizing the park. Dogs that become aggressive or uncontrollable while within or near the Dog Park must be immediately leashed and removed from the Dog Park and its surroundings. Reported cases will result in the loss of Dog Park privileges.
- (11) Dogs that are in heat or that are sick are prohibited from entering the park. All dogs must be licensed & properly immunized. The use of heartworm & tick prevention products is highly recommended.
- (12) Puppies over six (6) months of age must have full immunizations to utilize the park.

Puppies under the age of six (6) months are not permitted in the park.

(13) Dogs within the Dog Park must wear collars with valid dog licenses. No prong (pinch), choke or spiked collars are permitted in the park.

- (14) Keepers are responsible for ensuring that their dog only enters the appropriate fenced in area based upon the size and weight of their dog.
- (15) Keepers must immediately report any dog bites to the City of Millville Police Department.
- (16) Keepers must have their Dog Park Permit visible at all times.
- (17) Professional dog trainers are not permitted to use this facility for training purposes without written permission from the City
- (18) Keepers, guests and dogs must comply with this article, other laws, the terms and conditions of their Dog Park Permit, the application for same, the acceptance of risk and release of liability waiver form and other agreements signed by or for them or applicable to them, the City of Millville's regulations either posted or given to them or available at the City Clerk's offices or City of Millville website. Either the dog owner or other Keeper must maintain the required insurance for each of its dogs using the Dog Park.
- (19) Keepers must ensure that all gates are closed at all times after entering and exiting.
- B. Rules and Regulations shall be posted and may be changed by the governing body via resolution as appropriate.

§ 8-38 JOINT LIABILITY.

The Keeper of the dog who brings a dog to the Dog Park, if said person is not the owner of said dog, shall be responsible for any violations of this article. A summons may be issued to either the person bringing the dog to the dog park or the owner thereof who completed the application for a Dog Park Permit, or both, in the discretion of the individual issuing a summons.

§ 8-37 VIOLATIONS AND PENALTIES.

Any person who violates any section of this article or any of the rules or regulations promulgated pursuant to this article shall, upon conviction, be subject to a fine of up to \$2,000, imprisonment up to 90 days and/or community service up to 90 days in the discretion of the Municipal Court Judge and may be barred from further use of the Dog Park for such time as the Municipal Court Judge may determine.

SECTION 2

Should any provision of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

SECTION 3

This ordinance shall take effect twenty (20) days after final passage, according to law.

WHEREAS, the City's Control Officers have recently experienced difficulty in charging certain persons with violations of Chapter 8 of the City Code who despite being responsible for the care and control of the animal in question nevertheless cannot be charged under the language in the existing ordinance;

WHEREAS, persons frequently assume the care and control of animals by feeding them on a regular basis and yet deny ownership when being investigated for potential violations of Chapter 8 or N.J.S.A. 4:22-15 through 29;

WHEREAS, the Board of Commissioners of the City of Millville finds that it is necessary to broaden the definition contained in Section 8-2 of "owner" in order to prevent the cruelty to animals:

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Millville, County of Cumberland and State of New Jersey that Code Section 8-2 ("Definitions") is hereby amended as follows

SECTION 1

ATTACK DOG

Any dog or dog hybrid trained or baited to attack persons or animals.

DOG

Any dog or dog hybrid.

DOG OF LICENSING AGE

A dog which has attained the age of seven months or which possesses a set of permanent teeth.

DOMESTIC ANIMAL

Any cat, dog or livestock other than poultry.

GUARD DOG

Any dog trained to attack a person at the command or instruction of a trainer.

KENNEL

Any establishment where the business of boarding or selling dogs or breeding dogs for sale is carried on, except a pet shop.

LEASH

A chain, strap, cord or harness of sufficient substance to hold the animal under control and shall be no longer than 15 feet.

NUISANCE

Defecation or urination, destruction of property, disturbing the peace, emitting noxious odors, or otherwise endangering or offending the well being of the inhabitants of the City.

OWNER

Any adult who has an ownership interest in or who keeps or who harbors or who feeds an animal whether on his or her own place of abode or other location within the City.

PERSON

POLICE DOG

A dog actively engaged by a law enforcement agency to aid in its law enforcement duties.

POTENTIALLY DANGEROUS DOG

Any dog declared potentially dangerous by a Municipal Court pursuant to state law.

POUND

An establishment for the confinement of dogs seized either under the provisions of this chapter or otherwise.

PREMISES

Any parcel of land and any structures located thereon.

RUNNING AT LARGE

To be free of physical restraint or control beyond the boundaries of the premises of the owner.

SHELTER

Any establishment where animals are received, housed and distributed.

STRAY

Any animal found running at large.

TRAINER

Any person who trains or owns an attack dog or guard dog or from whom an attack dog or guard dog takes commands or instructions.

VICIOUS DOG

Any dog declared vicious by a Municipal Court pursuant to state law.

BOND ORDINANCE AUTHORIZING PURCHASES OF A FIRE TRUCK AND POLICE PATROL SPORT UTILITY VEHICLES AND APPROPRIATING THE SUM OF ONE MILLION SEVEN HUNDRED TWENTY THOUSAND DOLLARS (\$1,720,000) TO PAY THE COST THEREOF, TO AUTHORIZE THE ISSUANCE OF ONE MILLION SIX HUNDRED THIRTY-FOUR THOUSAND **DOLLARS** (\$1,634,000) OF BONDS TO **FINANCE** APPROPRIATION, AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF BONDS

THE BOARD OF COMMISSIONERS OF THE CITY OF MILLVILLE, IN THE COUNTY OF CUMBERLAND, STATE OF NEW JERSEY (not less than two-thirds of the full membership thereof affirmatively concurring), DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. <u>Appropriation for Projects-Down</u> <u>Payment</u>

The improvements described in Section 3 of this Bond Ordinance are hereby respectfully authorized as general capital improvements to be made or acquired by the City of Millville, in the County of Cumberland, New Jersey (the "City"). For said improvements or purposes stated in Section 3, there are hereby appropriated the sums of money therein stated as the appropriations made for said improvements or purposes, said sums being inclusive of all appropriations heretofore made therefore and amounting in the aggregate to ONE MILLION SEVEN HUNDRED TWENTY THOUSAND DOLLARS (\$1,720,000), including the aggregate sum of EIGHTY-SIX THOUSAND DOLLARS (\$86,000), which is hereby appropriated from the Capital Improvement Fund of the City as the down payments for said improvements or purposes as required pursuant to N.J.S.A. 40A:2-11. It is hereby determined and stated that the amount of the down payment is not less than five percent (5%) of the obligations authorized by this Bond Ordinance and that the amount appropriated as a down payment has been made available prior to final adoption of this Bond Ordinance by provisions in prior or current budgets of the City for capital improvements and down payments, including also monies received from the United States of America, the State of New Jersey or the County of Cumberland, or agencies thereof, as grants in aid of financing said improvements or purposes.

Section 2. Authorization of Bonds

For the financing of said improvements or purposes and to meet the ONE MILLION SEVEN

HUNDRED TWENTY THOUSAND DOLLARS (\$1,720,000) appropriation, negotiable bonds of the City are hereby authorized to be issued in the maximum principal amount of ONE MILLION SIX HUNDRED THIRTY-FOUR THOUSAND DOLLARS (\$1,634,000) pursuant to the Local Bond Law of New Jersey (the "Local Bond Law") and any other law applicable thereto. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes stated in Section 3, negotiable note(s) of the City in the maximum principal amount of ONE MILLION SIX HUNDRED THIRTY-FOUR THOUSAND DOLLARS (\$1,634,000) are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. <u>Description of Project</u>

The capital improvements hereby authorized and the purposes for the financing of which said obligations are to be issued, the appropriations made for and the estimated costs of such purposes (including all work or materials necessary therefore or incidental thereto), and the estimated maximum amount of bonds or notes to be issued for such purposes are as follows:

Section 4. Authorization of Notes

In anticipation of the issuance of said bonds and to temporarily finance said improvements, negotiable notes of the City in a principal amount equal to the said principal of bonds not exceeding ONE MILLION SIX HUNDRED THIRTY-FOUR THOUSAND **DOLLARS** (\$1,634,000) are hereby authorized to be issued pursuant to the limitations prescribed by the Local Bond Law. All such note(s) shall mature at such time as may be determined by the Chief Financial Officer or such other Financial Officer designated by Resolution for these purposes (both being hereinafter referred to in this Section as Chief Financial Officer); provided that no note shall mature later than one (1) year from its issue date.

Such note(s) shall bear interest at a rate or rates and shall be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with any note(s) issued pursuant to this Ordinance, and the signature of the Chief Financial Officer upon such note(s) shall be conclusive evidence as to all such determinations. The Chief Financial Officer is hereby authorized to sell the note(s) from time to time at public or private sale in such amounts as the Chief Financial Officer may determine and not less than par, and to deliver the same from time to time to the purchasers thereof upon receipt of the purchase price plus accrued interest from their dates to the date of delivery thereof as payment thereof. Such Chief Financial Officer is authorized and directed to report in writing to the Mayor and the Commission of the City at the meeting next succeeding the date when any sale or delivery of the note(s) pursuant to this Ordinance is made. Such report shall include the amount, the description, the interest rate, the maturity schedule of the note(s) sold, price obtained and the name of the purchaser. All note(s) issued hereunder may be renewed from time to time for periods not exceeding one (1) year for the time period specified in and in accordance with the provisions and limitations of N.J.S.A. 40A:2-8(a) of the Local Bond Law. The Chief Financial Officer is further directed to determine all matters in connection with said note or notes and not determined by this Ordinance. The Chief Financial Officer's signature upon said note(s) shall be conclusive evidence of such determination.

Section 5. <u>Capital Budget</u>

The capital budget of the City is hereby amended to conform with the provisions of this Bond Ordinance. The resolution in the form promulgated by the Local Finance Board showing full detail of the capital budget and capital program is on file with the Clerk and is available there for public inspection.

Section 6. Additional Matters

The following additional matters are hereby determined, declared and recited and stated:

- (a) <u>Capital Expenditures</u>. The said purposes described in Section 3 of this Bond Ordinance are not current expenses and are properties or improvements which the City may lawfully undertake as a self-liquidating purpose of a municipal public utility. No part of the cost thereof has been or shall be specifically assessed on property specifically benefited thereby.
- (b) <u>Average Period of Usefulness</u>. The period of usefulness of said purposes authorized herein as determined in accordance with the Local Bond Law is **9.42 years**.

- Supplemental Debt Statement. (c) supplemental debt statement required by the Local Bond Law has been duly prepared and filed in the office of the City Clerk and a complete duplicate thereof has been electronically filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, and such statement shows that the gross debt of the City as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by ONE MILLION SIX HUNDRED THIRTY-FOUR THOUSAND DOLLARS (\$1,634,000), and the said obligations authorized by this bond ordinance will be within the debt limitations prescribed by the Local Bond Law.
- (d) <u>Soft Costs</u>. Amounts not exceeding TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) in the aggregate for interest on said obligations, costs of issuing said obligations, architectural, engineering and inspection costs, legal expenses, a reasonable proportion of the compensation and expenses of employees of the City in connection with the acquisition of such improvement and property as authorized herein, and other items of expense listed in and permitted under Section 40A:2-20 of the Local Bond Law have been included as part of the costs of said improvement and are included in the foregoing estimate thereof.

Section 7. Ratification of Prior Actions

Any action taken by any officials of the City in connection with the improvements described in Section 3 hereof are hereby ratified and confirmed notwithstanding that such actions may have been taken prior to the effective date of this Bond Ordinance and shall be deemed to have been taken pursuant to this Bond Ordinance.

Section 8. Grants

Any grant moneys received for the purposes described in Section 3 hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this Bond Ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. Full Faith and Credit

The full faith and credit of the City are hereby pledged to punctual payment of the principal and interest on the said obligations authorized by this Bond Ordinance. Said obligations shall be direct, unlimited obligations of the City, and the City shall be obligated to

levy ad valorem taxes upon all of the taxable property within the City for the payment of said obligations and interest thereon without limitation of rate or amount.

Section 10. Official Intent to Reimburse Expenditures

The City reasonably expects to reimburse any expenditure towards the cost of the improvement or purpose described in Section 3 of this Bond Ordinance and paid prior to the issuance of any bonds or notes authorized by this Bond Ordinance with the proceeds of such bonds or notes. No funds from sources other than the bonds or notes authorized herein has been or is reasonably expected to be reserved, allocated on a longterm basis or otherwise set aside by the City, or any member of the same "control group" as the City, within the meaning of Treasury Regulations Section 1.150-1(f), pursuant to their budget or financial policies with respect to any expenditures to be reimbursed. This Section is intended to be and hereby is a declaration of the City's official intent to reimburse any expenditures towards the costs of the improvement or purpose described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with Treasury Regulations Section 1.103-18, and no action (or inaction) will be an artifice or device in accordance with Treasury Regulation Section yield restrictions or arbitrage rebate requirements.

Section 11. Effective Date.

This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by said Local Bond Law.

AN ORDINANCE AMENDING THE CODE OF THE CITY OF MILLVILLE TO ESTABLISH NEW REGULATIONS GOVERNING THE OPERATION OF FOOD TRUCKS/TRAILERS WITHIN THE CITY

WHEREAS, the Board of Commissioners of the City of Millville desires to facilitate the operation of food truck/trailers within the City on public and private property; and

WHEREAS, the Board of Commissioners finds that such food service operations promote the economic welfare of the City and enhance the quality of life of its residents; and

WHEREAS, the purpose of this Ordinance is to establish regulations governing the operation of food trucks/trailers:

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Millville that Millville City Code, Chapter 33 ("LICENSES AND PERMITS"), ARTICLE XVI ("Reserved") and ARTICLE XVII ("Street Vendors") are hereby amended as follows:

SECTION 1

ARTICLE XVI FOOD TRUCKS/TRAILERS

§33-120 License required, displayed, transferability, proof of insurance required, inspection required;

A. No person shall conduct, operate or maintain food truck/trailers without first obtaining a license to do so as required by the rules and procedures of the City of Millville City Code.

- B. No more than thirty (30) food truck/trailer vendor licensees shall be issued by the City. Such licenses are issued on a first come basis.
- C. Operators of food trucks/trailers shall affix to the vehicle a copy of the license issued by the City, the certificate of registration issued by the New Jersey Division of Taxation, and shall have displayed prominently on or adjacent to the doors of the vehicle, a placard or lettering with the name and address of the owner, lessee and/or lessor of the vehicle. Said information shall be in letters and numbers no less than three (3) inches in
- D. Food trucks/trailer licenses are not transferable.

height in accordance with N.J.S.A. 39:4-46.

- E. A license shall not issue unless proof of insurance is provided for:
- i. motor vehicle insurance as per N.J.S.A. § 39:6B-1
- ii. proof of general liability insurance providing a minimum of one million dollars (\$1,000,000.00) coverage
- F. Food trucks/trailers shall be inspected by both the Health Department and the Fire Department before operating. No changes shall be made to approved food trucks/trailers without re-inspection by both Departments.

§33-121 Time and Place of Operation

A. No food trucks/trailers shall occupy a public street and/or a sidewalk or any public park/recreation facility without special permission.

B. Food trucks/trailers shall only occupy private commercial properties with the expressed permission of the property owner on Monday through Friday from 7 AM to 3 PM, excluding public holidays. No more than two (2) food trucks/trailers shall be permitted on any single property at any given time. No food trucks/trailers shall occupy any portion of the public street and/or the sidewalk.

- C. Residents and not-for-profit organizations may request the presence of food trucks/trailers on their property for special occasions. Such request shall be made to the Borough Administrator who shall make a determination in his/her own discretion. Such determination shall include the number of trucks allowed and the hours of operation for same. No food trucks/trailers shall occupy any portion of a public street and/or a sidewalk.
- D. No food trucks/trailers shall operate or be parked in any area where parking of motor vehicles is prohibited, restricted or regulated.
- E. Property owners, residents and/or organizations giving permission to or requesting the presence of motorized food vendors shall assure that the food truck/trailer is parked legally and not obstructing the flow of vehicle or pedestrian traffic.
- F. Nothing in this chapter shall limit the City or any of its entities from the hiring of food trucks/trailers for special events in any quantity as they deem fit. The municipality may in its discretion utilize public property, public recreation facilities, streets and/or sidewalks for such events.

§33-122 Operation requirements for food trucks/trailers.

- A. Food truck/trailer operators shall provide trash and recycling receptacles within ten (10) feet of their site and shall collect all trash and debris within twenty-five (25) feet before leaving their site. Collected trash must not be deposited in public trash receptacles.
- B. All food trucks/trailers must abide by all existing traffic and parking regulations.
- C. No food trucks/trailers shall serve food or drink to a motorist or occupants of a vehicle.
- D. No motorized food vendor shall provide in-truck dining services or sidewalk tables and chairs.
- E. Food trucks/trailers shall be solely used for the

commercial use of food service and shall not contain sleeping quarters.

- F. Grills, generators, or other items related to the motorized food vending operation shall be physically attached to the vehicle
- G. Food trucks/trailers must have a portable water tank/sink for hand washing attached to their vehicle as per N.J.A.C. 8:24-5.3.
- H. All food trucks/trailers must abide by all existing traffic and parking regulations.

SECTION 2

ARTICLE XVII STREET VENDORS

§ 33-131 Purpose.

The purpose of this article is to regulate the manner in which street vending is conducted within the City and to provide standards for street vendors to insure the protection of the public health, safety and general welfare and to protect against consumer fraud and crime.

§ 33-132 Definitions.

As used in this article, the following terms shall have the following meanings unless the context clearly indicates that a different meaning is intended:

CANVASSER or SOLICITOR

Any person who travels about from house to house or store to store without appointment taking orders for future delivery of goods or services. The orders are not taken from a fixed location. Solicitation by telephone is not considered canvassing or soliciting within the context of this article.

HAWKER

Any person who moves about in the street or public places selling goods or wares by means of public outcry. The sales are not made from a fixed location and delivery of the goods or wares is made at the time of the sale.

HUCKSTER or PEDDLER

Any person who travels about from house to house or from store to store without appointment selling goods or wares. The sales are not made from a fixed location and delivery of the goods is made at the time of sale.

OUTSIDE SALESPERSON

Any person who travels about taking orders for future delivery of goods or services by calling on established customers and selected new customers by appointment at their place of business.

PERSON

A natural person, association, corporation, LLC, partnership, trust or other legal entity.

STREET VENDING

The selling of beverages, foods, merchandise, goods or wares by walking or driving about the City. It does not include selling from a fixed or permanent location.

STREET VENDOR

A street vendor includes a canvasser, solicitor, hawker, huckster and peddler.

VEHICULAR FOOD or BEVERAGE VENDOR

Any person traveling through the streets of the City in a motor vehicle stopping to sell food or beverages at retail to customers coming up to the vehicle is a "street vendor." An example of this is an ice cream truck. This does not include vehicles making deliveries to private residences or other locations.

§ 33-133 License required.

No person shall engage in street vending within the City unless licensed to do so pursuant to this article. The license required shall be known as a "street"

vendor license" and shall be issued by the City Clerk after payment of the required fee and compliance with these regulations. The fee for the license shall be \$25 per day for each licensee or \$400 per year.

§ 33-134 Application.

The application for the license required by this article shall be made in writing and filed with the City Clerk on a form provided by his office. The application shall contain the following information:

- A. The name and address of the applicant.
- B. The date of birth and driver's license number of the applicant.
- C. The name and address of the employer of the applicant.
- D. A brief description of the merchandise or products to be sold.
- E. The length of time for which the license is desired.
- F. The geographical area of the City where the applicant intends to operate.
- G. If a motor vehicle is to be used, provide a description of the motor vehicle and the tag number.

§ 33-135 Exemptions and waivers.

A. Interstate commerce. A canvasser or solicitor for the sale of goods or services who is engaged in interstate commerce shall not be required to obtain a street vendor license. However, said person shall be required to register with the City Clerk before conducting any canvassing or soliciting within the City. An application for a registration certificate shall be filed which contains the following information: the name and address of the applicant, name and address of the applicant's employer and the nature of the business. No registration certificate shall be issued for 48 hours after the application is filed so that the Chief of Police or his designee has sufficient time to conduct a

background investigation on the applicant to determine whether the applicant has been convicted of a criminal offense involving moral turpitude or any other offense involving consumer fraud.

- B. Outside salespersons are exempt from the licensing fee and the regulations contained in this article.
- C. Veterans and other persons named in N.J.S.A. 45:24-9 are exempt from the licensing fee and licensing requirements applicable to street vendors, but they are subject to the regulations affecting them. However, if veterans or other persons named in N.J.S.A. 45:24-9 engage in any other activity which is required to be licensed by any other article of this chapter, they are subject to the applicable licensing fees, licensing requirements and regulations.
- D. Food trucks/trailers are governed by Article XVI and are therefore exempt from this Article.

SECTION 3

Should any provision of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

SECTION 4

This ordinance shall take effect twenty (20) days after final passage, according to law.

Bids must be on the bid form prepared by Remington & Vernick Engineers, in the manner designated therein and required by the specifications, must be enclosed in sealed envelopes bearing the name and address of the bidder on the outside and also bearing on the outside reference to the particular work bid upon. Said bids shall be addressed to the Purchasing Board of the City of Millville located at 12 S. High Street, Millville, New Jersey 08332.

Each bid shall be accompanied by a certified check, cashier's check or bid bond duly executed by the bidder as principal and having as surety thereon a surety company approved by the **City of Millville** in an amount not less than ten percent (10%) but in no case in excess of \$20,000.00 of the amount bid. Any such bid bond shall be without endorsement or conditions. Bid shall also be accompanied by a certificate letter from a surety company stating that it will provide the bidder with the completion bond.

The award of the contract shall be made subject to the necessary moneys to do the work being provided by the **City of Millville** in a lawful manner. The contract to be executed by the successful bidder will provide that it shall not become effective until the necessary moneys to do the work have been provided by the **City of Millville** in a lawful manner. The award shall further be subjected to the securing of necessary State, Federal or Local permits governing the work.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq., N.J.A.C. 17:27 (Affirmative Action), N.J.S.A. 34:11-56.25 et seq. (New Jersey Prevailing Wage Act), and Americans with Disabilities Act of 1990 (42 U.S.C. S12101, et seq.).
